2.0. Forecast Spend

Forecast spend remains on target to be met and not exceeded. LCC has indicated that the Accessible Nelson project may continue until December 2026. The Trafalgar House element of the Revitalised Nelson project may continue until March 2027 depending on final programme.

The programme for Wavelengths is currently forecast for completion for March 2026, as is PRSC. Both are being closely monitored. The expenditure profiles for Business Resilience and Digital Skills Academy (Spoke) are also being closely monitored. This is due to the dependency on third party grant recipients to deliver their individual funded projects on time in the Business Resilience programme, and the delay in the lease for the ACE Centre to enable the Digital Spoke at the Ace Centre to be set up.
