# MISCELLANEOUS MATTERS

9. <u>Maintenance of Barrowford Road Playing Fields</u>

At the request of this Committee a meeting was held on Friday 6<sup>th</sup> June between Pendle Council's Director of Place, Greenspaces Officer, Senior Parks Officer and Nelson and Colne College.

Issues were discussed around communications regarding the site from third parties and how/who should respond. It was agreed that all enquiries regarding the site should be directed to the college directly as they are the landowner.

Current maintenance of the site was discussed at length regarding obligations under the S106 Agreement. Pendle Council are to provide a formal quote to the college for additional works currently not carried out, to included sanding, fertiliser and herbicide. The Council will then await further instruction.

#### 10. <u>Representatives on Outside Bodies</u>

At the last meeting of this Committee, Members were asked to appoint four representatives to the Hartley Homes Trust.

Further to the decision of the Committee, the Trust was asked if one nomination would be satisfactory, given that two of the Life Trustees are members of the Colne and District Committee.

Members are advised that the composition of the Trust is governed by a Charity Commission Scheme. The Commission has decided that 11 trustees is the appropriate number and provides for seven Life Trustees appointed by the Trust itself, and four Trustees nominated by Pendle Council. However, should the Committee choose to nominate only one representative, the decision will be accepted.

#### 11. Wheel Park, Vivary Way, Colne

The Assistant Director, Operational Services provides the following update on progress with the Wheel Park, Vivary Way, Colne.

Members are advised that following the production of the drawings seen at the May meeting, the Council is looking to proceed to the next stage of formal planning permission for the scheme, prior to searching for external funding.

Concerns have been raised around this scheme based on the potential for anti-social behaviour, parking issues and potential personal injury that could affect the leisure centre. It has been asked for consideration for the site to be located at Alkincoats Park instead.

Colne Town Council has been written to asking for opinion on this suggestion.

Officers have met recently with the police regarding the location and they are very supportive of its current proposed site adjacent to BMW and believe it will be good for the local community.

A site meeting is being held with Borough Engineers to look at parking options as ANPR on the Pendle Leisure Trust car park has now prevented any wheel park users using the existing parking available which could potentially cause a planning issue.

When these issues have been resolved / investigated further, the scheme can continue as planned.
