Didn't turn up at

						Court so arrest warrant issued. Pleaded not guilty – trial set for 29th July 2025 Fined £3402.50 considering Injunction if breach continues Wrote to defendant indicating we will consider an injunction should he not comply with the notice.
2. Land South of Heights House, Heights Lane, Fence	3944	17/11/22	28/11/22	09/01/23	09/02/23	Enforcement Notice served requiring the owner to permanently remove the caravan from the land and cease using the land for non-agricultural purposes and to remove all the hardstanding and sub base material and reinstate the grassed field and wall to its former condition. Appeal dismissed. The defendant pleaded guilty in court on 22nd May 2024 and was fined. Further work undertaken which needs to be checked on

						site for compliance. Planning to check. JBG and NW visited site. Asked for updates on outstanding matters. Awaiting response.

Land adjacent Pasture Barn East, Pasture Lane, Barrowford	1783104	Delegated	16/05/25	20/06/25	20/09/25	Enforcement Notice to cease using the land for any purpose other than agriculture and to remove the mobile structures, wooden decking, fire pits, logs and other items. Not guilty plea. Trial 19th March 2025. Prosecution withdrawn due to legal issues. Further EN served 16/05/25 Appeal in progress

Land to the East of Pendle House Farm, Barley Lane, Barley, BB9 6LG	1799960		11/06/25	09/07/25	09/10/25	Enforcement Notice requiring to Remove the building from the land and permanently remove all materials from the land used in the construction of the building. Appeal submitted and awaiting decision from PINS

5. Land part of Forest of Pendle Leisure Park	1911620	26/11/25	06/01/26	12/04/26 29/08/26	Enforcement Notice requiring: 1. The removal of all caravan bases and associated roadways. 2. Reprofilling of the land so that it matches the original contours and landform that existed prior to the engineering works. 3. Re-seeding the land with grass. Steps 1 and 2: must be completed within 3 months. Step 3: must be completed within 9 months.
