I AM WRITING TO FORMALLY OBJECT TO THE PROPOSED OPENING OF LE KOEKOK. THE OPENING OF ANOTHER BAR IN THE AREA WILL CAUSE SEVERE DETRIMENT TO LOCAL RESIDENTS, MY OBJECTIONS ARE GROUNDED IN THE FOLLOWING AREAS:

LATE NIGHT NOISE & VIBRATION: TERMINAL HOURS OF 00:30 AND 02:30 WILL INEVITABLY CAUSE SEVERE SLEEP DISTURBANCE TO NEARBY RESIDENTS THROUGH CUSTOMER DISPERSAL, OUTDOOR SMOKING AND LIVE MUSIC.

PRECEDENT OF ANTI-SOCIAL BEHAVIOUR: LOCAL RESIDENTS ALREADY EXPERIENCE REGULAR PUBLIC NUISANCE FROM EXISTING LATE-NIGHT ESTABLISHMENTS INCLUDING DISCARDED GLASSWARE ON WINDOW SILLS, PUBLIC VOMITTING AND HUMAN EXCREMENT ON THE NEARBY STREETS. ALLOWING ANOTHER VENUE TO OPERATE INTO THE EARLY HOURS WILL SIGNIFICANTLY COMPOUND THESE EXISTING PUBLIC HEALTH AND NUISANCE ISSUES.

INSUFFICIENT PARKING PROVISION :  
PARKING IN THIS SPECIFIC AREA IS ALREADY AT MAXIMUM CAPACITY. THE APPLICATION MAKES NO VIABLE PROVISION FOR THE INFUX OF ADDITIONAL VEHICLES, WHICH WILL LEAD TO CHAOTIC, DANGEROUS OBSTRUCTION OF RESIDENTIAL HIGHWAYS.

HAZARDOUS JUNCTION LAYOUT :  
THE JUNCTION OF INGHAM STREET LEADING INTO GISBURN ROAD IS ALREADY A POTENTIAL ACCIDENT HOTSPOT. THE ABSENCE OF DOUBLE YELLOW LINES CREATES BLIND SPOTS DUE TO PARKED CARS. I HAVE PERSONALLY EXPERIENCED MULTIPLE NEAR MISS COLLISIONS AT THIS JUNCTION. INCREASED LATE-NIGHT VEHICLE MOVEMENTS (INCLUDING DELIVERY DRIVERS, TAXIS, AND PATRONS) WILL DRASTICALLY ELEVATE THE RISK OF A SERIOUS TRAFFIC ACCIDENT.
