I WISH TO OBJECT TO THE APPLICATION ON THE GROUNDS OF THE PREVENTION OF PUBLIC NUISANCE.

ALTHOUGH THE PREMISES IS SITUATED ON THE MAIN ROAD OF G ISBURN ROAD, IT IS ALSO ON THE CORNER OF INGHAM STREET, WHICH LEADS TO THE RESIDENTIAL AREA IMMEDIATELY BEHIND AND AROUND THE SURROUNDING AREA.

I AM CONCERNED THAT THE PROPOSED HOURS SEVEN DAYS A WEEK, BUT PARTICULARLY AT THE WEEKENDS; SERVING ALCOHOL UNTIL 2.00 AM CLOSING AT 2.30 AM, EVERY FRIDAY, SATURDAY & SUNDAYS, ARE EXCESSIVE FOR THIS AREA AND ARE LIKELY TO CAUSE SIGNIFICANT DISTURBANCE TO NEARBY RESIDENTS.

MY CONCERNS RELATE PARTICULARLY TO NOISE FROM CUSTOMERS LEAVING THE PREMISES LATE AT NIGHT, INCLUDING SHOUTING, LOUD CONVERSATIONS, VEHICLE NOISE, TAXI COLLECTIONS, CAR DOORS AND GENERAL ANTI-SOCIAL DISTURBANCE DURING EARLY MORNING HOURS WHEN RESIDENTS ARE TRYING TO SLEEP.

THERE IS ALSO VERY LIMITED PARKING IN THE IMMEDIATE AREA. THIS IS LIKELY TO CAUSE EVEN MORE CONGESTION IN THIS AREA, INCONSIDERATE PARKING AND ADDITIONAL DISTURBANCE WITHIN NEARBY RESIDENTIAL STREETS.

IN ADDITION, THERE ARE ALREADY TWO SIMILAR VENUES OPERATING IN CLOSE PROXIMITY, BOTH WITH LICENSES ( [REDACTED] AND [REDACTED] ), NEITHER OF WHICH OPERATES ANYWHERE NEAR THE HOURS BEING REQUESTED IN THIS APPLICATION. THE PROPOSED HOURS THEREFORE APPEAR OUT OF KEEPING WITH THE AREA & WOULD LIKELY ADD TO CUMULATIVE DISTURBANCE & NUISANCE FOR LOCAL RESIDENTS.

I RESPECTFULLY ASK THE LICENSING AUTHORITY TO REFUSE THE APPLICATION AS SUBMITTED, OR AT THE VERY LEAST TO SIGNIFICANTLY REDUCE THE PROPOSED OPERATING HOURS TO MORE REASONABLE TIMES IN KEEPING WITH SURROUNDING AREA & EXISTING NEARBY VENUES.
