1. Executive Summary

- 1.1 The budget for 2026/27 is £78,270 but the committee was £23,370 underspent at the end of 2025/26 (see Financial Implications 6.4). The total funds available for 2026/27 is £156,540. This has been committed in accordance with the budget table set out in Appendix 1.
- 1.2 Budget Overcommitted:
 At the Committee meeting held on 11 May, the budget was overcommitted. The budget therefore needed to be reviewed and reallocated in line with the funds available. £16,500 was committed on 6 July leaving £43,900 available for reallocation.
- 1.3 Bids:
Bid £1,500 - Pendle United Cricket Club, Supporting Grassroots Cricket (Appendix. 2). This is to be reconsidered as per paragraph 1.2.
Bid £50 – Friends of Victoria Park, Public Liability Insurance for events in Victoria Park (Appendix 3)
Bid £4,000 – PBC, Nelson & Colne College Path Improvements (Appendix 4)

If so, please give details: We submitted a bid to Nelson PiP for funding to complete improvements to the path between Nelson & Colne College and Scotland Road where Accessible Nelson starts. The total cost of the project is £84,000 including revenue. We have approval from PiP for £56,000. We recently received approval of a bid to Nelson Town Council for £10,000 and we are waiting for confirmation from LCC that they will overlay a section of the path which accounts for £10,000. The remaining shortfall is therefore £8,000. We are asking Nelson Area Committee and Barrowford Area Committee for £4,000 each.

19. Details of project: Accessible Nelson will create safer routes to walk and cycle from Scotland Road to Nelson Interchange. Improvements to the route between the Nelson & Colne College to Scotland Road might encourage people to walk or cycle to and from Nelson Interchange to connect to train and bus routes. The main purpose of the scheme, however, is to make the route feel safer, especially for women and girls, during the darker winter months. The project will include improved softer lighting in the 3 underpasses on the route; decorative and festoon lighting in some of the trees in 3 locations on the route; solar lighting in the middle of the path; we aim to work with students from Nelson and Colne College to include some artwork in the grassed areas between the underpasses and perhaps continue this through the subways; artwork will include decorating some benches. The artwork will include consultations with student from the college, particularly targeting women and girls. See attached proposed plan.

20. Main outcomes to be achieved: The main outcomes to be achieved will be to make the route feel more attractive and maintained to increase footfall and cycle use and to ultimately make the route feel safer. We would like to encourage more students to cycle or walk to college and perhaps use the train or bus rather than travel by car. It will also improve the link between Barrowford and Nelson Interchange giving Barrowford residents more opportunity to choose sustainable transport/travel for onward journeys.

21. When will project be implemented?

Start Date: September 2026

Expected Completion Date: March 2027 depending on permissions being received from LCC who own the land and the subways

22. Who will undertake the project works? LCC and other contractors for individual parts of the scheme. The whole scheme will be managed/overseen by PBC Engineers.

23. Are there long-term revenue consequences and how will these be funded?

Part of the scheme will be cutting back shrubs from around the subway entrances, and we have planted wildflower beds along the route. Pendle Council's Operational Services already maintain the grass and shrubs on behalf of LCC at this location. However, we will be liaising with the college's horticulture section to find out if they might help to maintain and improve the route going forward for example, they could add to the wildflowers and planting along the route. This will give them a sense of ownership. Therefore, there are no additional costs required for ongoing maintenance.
