1. Summary

Unspent 2025/26 Funds Carried Forward

1.1 This is £30,553.55

- Barnoldswick - £17,034.90
- Earby - £5,553.05
- Coates - £4,156.68
- Kelbrook & Sough - £1,826.42
- Salterforth - £881.95
- Credit balance litter & dog waste bins £1,100.55

Uncommitted Balance from 2025/26

1.2 This is £0.00.

Allocation for 2026/27

1.3 This is £31,490 split by electorate areas. This is:

- Barnoldswick – 50.4% = £15,870.96
- Earby – 24.8% = £7,809.52
- Coates – 13.3% = £4,188.17
- Kelbrook & Sough – 6% = £1,889.40

- Salterforth – 5.5% = £1,731.95

Credit balance for litter and dog waste bins for 2026/27

1.4 This is £1,100.55

Due to an error with the budget at the end of the financial year 2024/25 there was a credit of £1,395.00 for new litter and dog waste bins in 2025/26. The balance from this carried forward to 2026/27 is £1,100.55. This is shown on a separate table at appendix 12. The credit can be used in any of the 5 areas for new litter and dog waste bins.

Effective Total Allocation for 2026/27

1.5 This is £32,590.55

- Credit balance: Litter and Dog Waste Bins: £1,100.55

New/Deferred Bids

1.8 Following a site visit on the 30th July Members are asked to consider the bid from the Robert Windle Foundation, seeking £7,000 from the Earby allocation for roof repairs – see Appendix 7. This was deferred from the July meeting for a site visit.

Existing Allocations - any overspends (additional funding required); underspends (de-allocate funding) or virements (re-allocate funding) - to report:

1.9 At the June meeting it was agreed to deallocate £2,000 from the Premises Improvement Grants, item 47, Appendix 1 and for the deallocated £2,000 to be reallocated to resurfacing the footpath at Church Primary School, item 57,

Appendix 1. The Premises Improvement Grants funding was thereby reduced to £4,000.

However, our Economic Growth Team have received 4 bids to the Premises Improvement Grant Scheme as follows: £1,500 paid; £1,500 and £1,080 allocated but not yet paid and this will bring the total to £4,080. They have also received a new application for £1,500.

Members to decide whether to deallocate £80 to cover the shortfall and £1,500 for the new application from elsewhere in the Barnoldswick budget.

There is the opportunity to allocate some of the Legacy Fund Barnoldswick allocation, see separate Legacy Fund Report, towards the Premises Improvement Grants instead.

2. Recommendations

- 2.1 Note that only the schemes listed in Appendices 1, 2, 3, 4 and 5 have agreed funding to date for 2026/27.

- 2.3 Note the credit balance b/f for litter and dog waste bins at Appendix 6.
- 2.4 Consider the resubmitted bid from Robert Windle Foundation at item 1.8 and bid form at Appendix 7.
- 2.5 Note item 1.9 regarding the Premises Improvement Grants for Barnoldswick – Appendix 1, item 47 - and advise what action to take.
- 2.6 Note the separate Legacy Fund Report.

- 3.1 To enable the committee to allocate its budget effectively and in line with financial regulations.

- 6.3 Schemes should be completed and payment made by 31 March as any slippage will need to be agreed by the Council in line with Financial Regulations.
- 6.4 The maximum carry forward figure is £31,490 as it is capped at the equivalent of 1 year's budget. If the committee have more than £31,490 unspent at the end of the year it will need to use the following year's budget to make up the difference.
